### Are services subject to sales tax in Mississippi?

"Goods" refers to the sale of tangible personal property, which are generally taxable. "Services" refers to the sale of labor or non-tangibles. In Mississippi, specified services are taxable. ### Local Sales Taxes in Mississippi

Municipal governments in Mississippi are also allowed to collect a [local-option sales tax](#) that ranges from 0% to 1% across the state, with an average local tax of 0.052% (for a total of 7.052% when combined with the state sales tax). The maximum local tax rate allowed by Mississippi law is 1%. Below are listed local sales tax rates for the five largest cities in Mississippi.
