### Are services subject to sales tax in Vermont?

"Goods" refers to the sale of tangible personal property, which are generally taxable. "Services" refers to the sale of labor or non-tangibles. In Vermont, specified services are taxable. ### Local Sales Taxes in Vermont

Municipal governments in Vermont are also allowed to collect a **local-option sales tax** that ranges from 0% to 1% across the state, with an average local tax of 0.092% (for a total of 6.092% when combined with the state sales tax). The maximum local tax rate allowed by Vermont law is 1%. Below are listed local sales tax rates for the five largest cities in Vermont.
