### What is exempt from sales taxes in Florida?

Many states have special sales tax rates that apply to the purchase of certain types of goods, or fully exempt them from the sales tax altogether. Here's how Florida taxes five types of commonly-exempted goods:

### Are services subject to sales tax in Florida?

"Goods" refers to the sale of tangible personal property, which are generally taxable. "Services" refers to the sale of labor or non-tangibles. In Florida, specified services are taxable. ### Local Sales Taxes in Florida

Municipal governments in Florida are also allowed to collect a **local-option sales tax** that ranges from 0.00% to 2.00% across the state, with an average local tax of 0.829% (for a total of 6.829% when combined with the state sales tax). The maximum local tax rate allowed by Florida law is 1.50%. Below are listed local sales tax rates for the five largest cities in Florida.
