### What is exempt from sales taxes in Hawaii?

Many states have special sales tax rates that apply to the purchase of certain types of goods, or fully exempt them from the sales tax altogether. Here's how Hawaii taxes five types of commonly-exempted goods:

### Are services subject to sales tax in Hawaii?

"Goods" refers to the sale of tangible personal property, which are generally taxable. "Services" refers to the sale of labor or non-tangibles. In Hawaii, services are taxable unless specifically exempted. ### Local Sales Taxes in Hawaii

Municipal governments in Hawaii are also allowed to collect a **local-option sales tax** that ranges from 0% to 0.5% across the state, with an average local tax of 0.427% (for a total of 4.427% when combined with the state sales tax). The maximum local tax rate allowed by Hawaii law is 0.5%. Below are listed local sales tax rates for the five largest cities in Hawaii.
